- User agrees to pay Purpose Church _____ for the use of the premises.
 - Non-Fee Agreement. In consideration for the benefit of using Purpose Church, User agrees to abide by all the terms and conditions of use described in this agreement.
 - User agrees that they will not use the premises for any unlawful purposes, and will obey all laws, rules, and regulations of all governmental authorities while using the above described facilities.
 - User agrees that they will not use the premises for any purpose that is contrary to the mission, purpose or belief of Purpose Church, which is a biblically-based religious institution.
 - User agrees to abide by any rules or regulations for the use of the premises that are attached to this agreement.
 - User agrees that they are solely responsible to implement appropriate screening and supervision procedures to protect children, youth, and vulnerable adults attending the user's function at Purpose Church.
 - User promises and warrants that they will obtain signed Activity Participation Agreements from each participant in the activity. If the participants are minors, user will obtain the signature of at least one parent or legal guardian on each Activity Participation Agreement.
 - User agrees to pay the fee of \$15 each for use of linen tablecloths.
 - User agrees to hold harmless, indemnify and defend Purpose Church (including Pastors Joel and Theresa Arwood, or any other staff members or representatives of Purpose Church) from any liability for injury or damage including but not limited to, illness, exposure to infectious/communicable disease, bodily injury, personal injury, emotional injury, or property damage which may result from any

person using the above described premises, its entrances and exits, and surrounding areas, for User's purposes, regardless of whether such injury or damage results from negligence of Purpose Church or otherwise.

- User agrees to be responsible for preparing for use and returning to the pre-use condition all areas of the premises which User will use, including entrances and exits.
- User agrees to conduct a visual inspection of the premises, including entrances and exits, prior to each use, and warrants that the premises will be used only if it is in safe condition.
- This agreement may be cancelled unilaterally by either party with 14 days written notice to the other party.
 - In the event that Purpose Church must cancel this agreement, User will be entitled to any deposit the user has paid. However, in no event will Purpose Church be liable to User for any lost profits or incidental, indirect, special, or consequential damages arising out of User's inability to use the above described premises, even if Purpose Church has been advised of the possibility of such damages.
- User agrees that they will not assign any of its rights under this agreement, and any such assignment will void this agreement at the sole option of Purpose Church.
- Purpose Church and User agrees that any disputes arising under this agreement will be resolved via mutually acceptable alternative dispute resolution process.

- This document contains the entire agreement of the parties and superseded all prior written or oral agreements relating to the subject matter
